1. Project Highlight



GS E&C made a construction contract with 'Majordevelopment Corp.' about Hapjung mixed-use development project on September 14, 2007. Total contract amount is KRW 405 billion, and GS E&C will construct one office building and three residential & store buildings.

Each self-governing Gu designates an area to develop well-balanced city through construction of mixed-use complex in the area.

Hapjung district was designated by Seoul City in 2003, and approved business execution last May 25. It is the first business approval among other eight development area to develop balanced Seoul city.

Currently, Hapjung balance development district is under business processing by 'Majordevelopment Corp.' The area will be developed as a mixed-use complex such as office, commercial, residential and cultural fusion complex.



3. Significance & Prospect

Significance of the Project

Hapjungdong project is a combination of a 34 stories office building with 44,901 m² total floor area and three housing buildings which are 29~39 stories residential and commercial apartment buildings. In addition, residents can enjoy one-stop shopping such as mart, movie theater, and various commercial facilities including small park. As a landmark in Gangbook area as well as Mapogu, Hapjungdong complex will help economic activation of Mapogu and city decentralization.

GS E&C's award of Hapjung mixed-use development project proved superior proposal ability for development project and construction excellence since designation as a Preferred bidder for Ansan sadong development project and Sungnam-Pangyo complex PF business. Hapjungdong mixed-use development project will contribute to KRW 100 bn of sales revenue per year for the next 4 years.

Through cumulative construction experiences and development ability, Hapjungdong mixed-use complex award raised possibility of GS E&C's success in overseas development businesses in NGE (New Growth Engine) countries.
